

River Permit Info and Links for January 2025 Planning and Permit Party

The following includes info for lottery permitted rivers that club members have paddled in the past as well as a brief step by step process and the club etiquette for participation as part of a canoe club group. The deadline for most (not all) lottery applications is January 31. Permit notifications for most rivers (not all) is mid-Feb.

Canoe Club Permit Lottery Etiquette:

Joining with others in a lottery "assault" carries both rights and obligations which you should understand. Each person who hopes to go on any particular trip should enter the lottery for that trip. All family members who hope to go on the trip should enter the lottery individually. For those of us who belong to multiple clubs, we should join a permit lottery group with only one club for each river we are interested in.

For example, someone who is a member of both Poudre Paddlers and the Canoe Club may decide to join with the Canoe Club group attempting to get a permit for the Smith River, and join with the Poudre Paddlers group attempting to get a Desolation Grey permit. They would not join groups from both clubs for the same river. This goes for those who are also Raft Club members.

If you are lucky enough to catch a permit, you should first look to extend trip invitations to the others in the club with whom you submitted in the lottery for that river. That's why it's important to keep track of who's applying. But we all understand that many of our paddlers have been previously invited on other trips (both club and non-club) and that this creates an additional and sometimes conflicting etiquette to invite those generous trip leaders on your trip if you get a permit.

Ultimately, who and how many boaters go on any of our club trips is up to the Trip Coordinator. On lottery permit trips, final decisions belong to the permit holder, just as they do for any Trip Coordinator. Decisions regarding skills, safety, desired number of boaters, and personalities can always come into play. And, as some would say, Karma rules here as it does in much of life.

Here is a brief step by step on the process

1. Research rivers to assess your interest and to see if you possess the required skills and experience. Each river listed below has a link where you can find info. Other resources are also listed below.
2. Add your name to rivers of interest on the Interest Survey when it becomes available January 1, 2025 (club members will receive a link to the Survey then).
3. Come to the Permit and Planning Party January 12, 2025 (or attend virtually). There will be a chance to talk to others interested in the same river. After the party, everyone will be able to see who else expressed similar interests and can initiate communication with each other to finalize groups, desired dates and strategies for obtaining a permit. .
4. **Apply to the lottery by Jan 31!** (see below for rivers with different deadlines.) Each person who wants to go on a canoe club trip submits a lottery application for each river of interest, selecting their desired dates—using whatever strategy your group has decided on and records their submission dates on the shared Google doc..

*****Permits are NOT transferable. If you receive a permit, you must be able to make the trip or the trip won't go. (Some rivers may allow a back up person. Most do not.)*****

5. Watch for notifications of permits granted. Announcement dates are listed below for each river. Most announcements are mid-Feb.
6. Celebrate if someone receives a permit! Plan your Trip!
7. OR plan attempts for cancellations. Info on pursuing cancellations can be found through the links listed below for each river.

Rivers in Colorado

Yampa and Green Rivers in Dinosaur National Monument

Lodore: Class III-IV 44 miles

Yampa: Class II-III(IV) 71 miles

High Use Season: May 12 – Sept 12 (Green); May 12 – July 12 (Yampa)

Low Use Season reservations: Beginning Mar 4 (also one-day and unclaimed High Use trips)

High Use Season Lottery Dates: December 1 - January 31st

Permit Acceptance Date: Mar 1

Lottery Notification Date: February 12th (estimated)

Lottery fee: \$15.

Permit fee (if successful in the lottery): \$185 – due on Mar 1 2024, 10 pm (MT)

Flows: 500 cfs is considered minimum by many canoeists, but it has been run lower. Use your own judgment. Historical average flow for Yampa at end of July is 500 cfs

Difficulty: Class I – III (or IV at some water levels)

Over-length Trip Fee \$35.00. During the High-use season, the normal trip length for river trips is five days on the Yampa River and four days on the Green River. When applying for a permit, you may apply for an additional day on your trip.

Colorado River – Ruby Horsethief (aka Loma to Westwater)

Class I-II 25 river miles

Not a lottery but an on-line reservation system. Reservations can be made 60 days before the launch date.

High Use Season: April 1 – Oct 31 [Camping fees are charged during this period.]

Note: Reservations are for campsites and they're highly competitive for late spring, summer, and early fall Saturdays. Reservations can be made 60 days before the launch date. Between May and Nov, reservations can be made after 8am Mountain time.

Reservation costs: \$6 plus the cost of the campsite (\$20 - \$100/night depending on group size. 25 heartbeats =group max. 2 dogs allowed. 1-5 heartbeats=\$20/nite; 6-14=\$50/nite; 15-25=\$100/nite)

Note: reservations are required year round For Ruby Horsethief trips, but campsites are free outside of the High Use Season

Flows: Between 2000 – 4000 cfs, beginning canoe skills. Between 5000 and 10000cfs, advanced canoeing skill required.

Montana

*****Again, please note that our intention is to be as accurate as possible with the river info below. Please use the links provided to double check the official word! Montana has made several changes in the past year, particularly to significantly reduce permits available for out of state boaters.*****

Smith River – Camp Baker to Eden Bridge

Class I-II - 60 river miles

Permit required all year. High season May 15 – July 15 (max 4 nights on river. max group=15; no dogs.

Shoulder Season (non lottery): September - October; self registration at put-in. Number of days not limited.

Lottery Permits available for trips April 1 - August 15.

Lottery application dates: January 2, 2025 through February 15, 2025

Note 1: Applicants will have only one launch date choice, instead of three choices.

Note 2: The number of permits available for nonresidents may not exceed 10 percent of the available permits. (This new law was passed as part of House Bill 846 in the 2023 Legislative Session.)

Lottery application fee: \$15 *see website for additional "super permit" info)

Permit fee: \$60 for non-Montana resident adults

Lottery Drawing: February 19, 2025

(note: FWP will notify successful applicants by email. FWP does not notify unsuccessful permit applicants. Lottery results will also be available at myfwp.mt.gov)

Flows: Montana State Parks says the canoe minimum is 150 cfs. 300-500 is more realistic.

(***A river ranger told us in 2023 that 110 - 120 cfs is reasonable for a canoe but they say 150 cfs to be conservative. Katherine had a great trip Oct. 2023 at 190 cfs. (Paddlers were in kayaks.)
